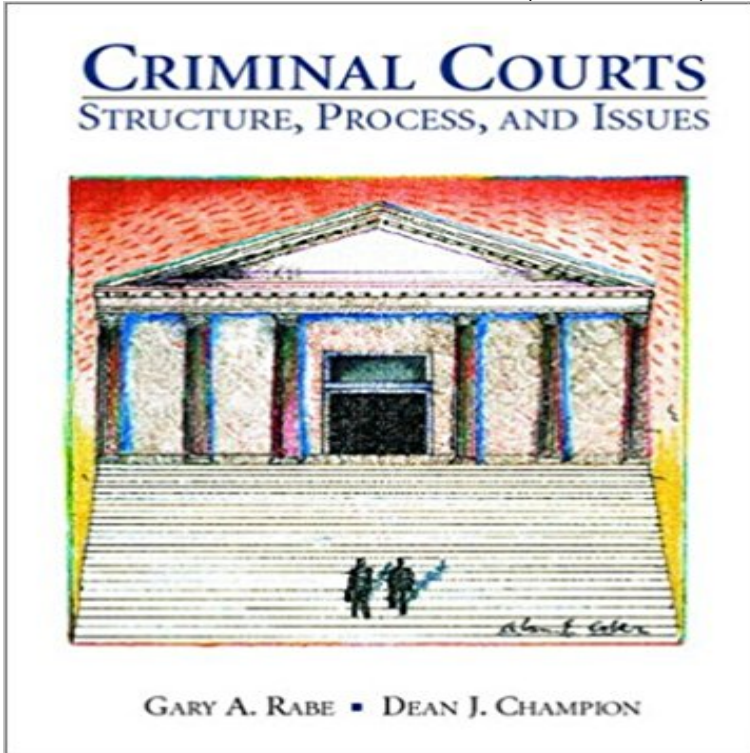


# Criminal Courts: Structure, Process, and Issues
