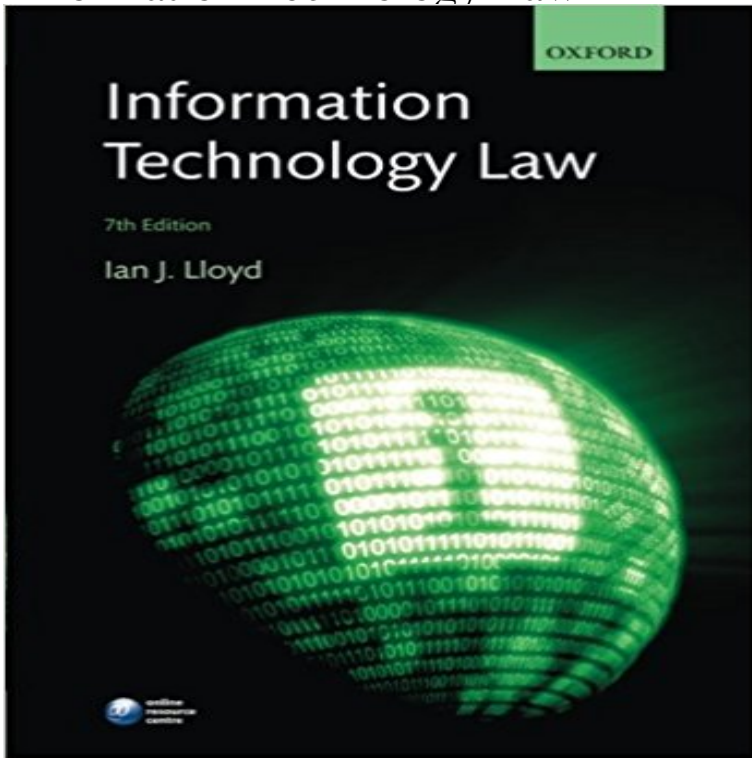


## Information Technology Law
