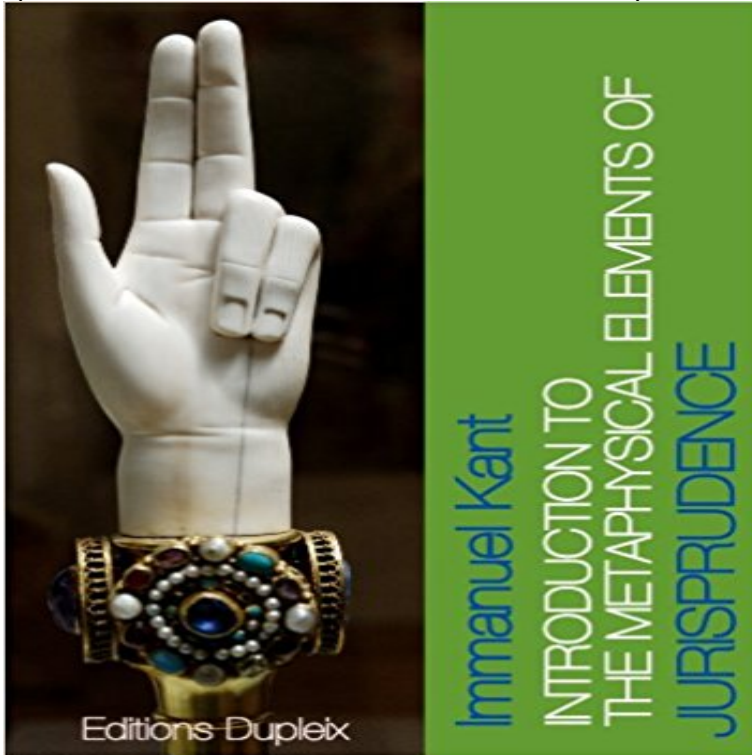


Introduction to the metaphysical elements of jurisprudence (Annotated) (Humanities Collections Book 6)
