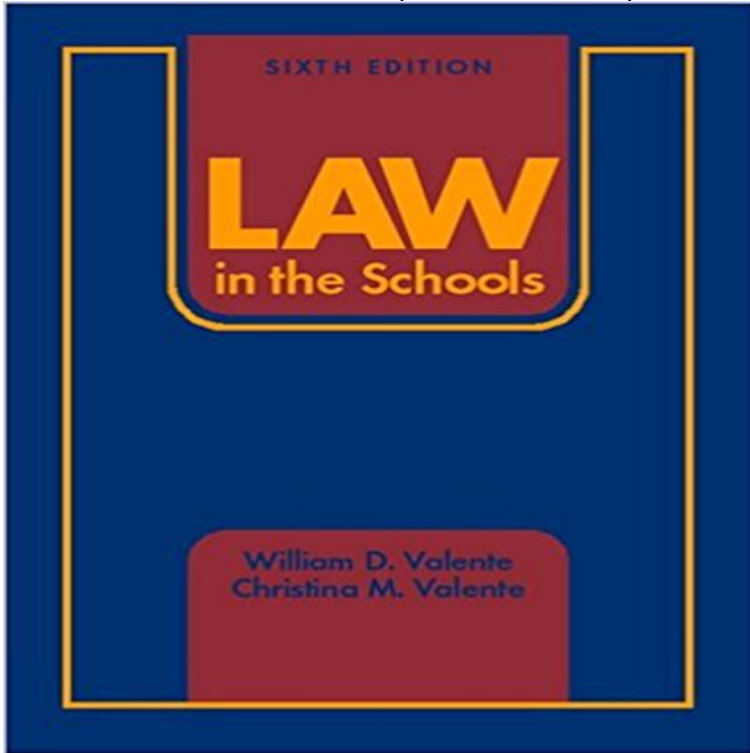


## Law in the Schools (6th Edition)
