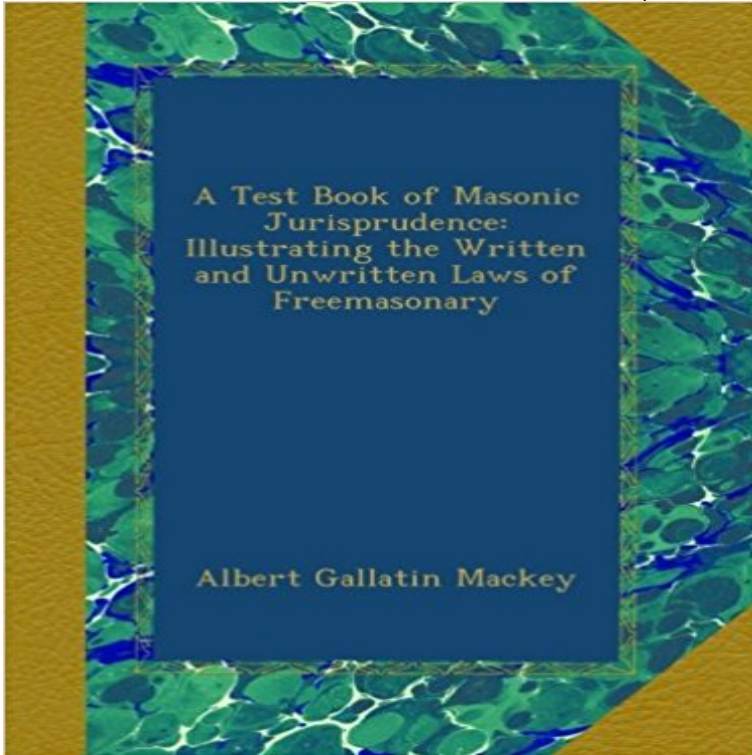


# A Test Book of Masonic Jurisprudence: Illustrating the Written and Unwritten Laws of Freemasonry
