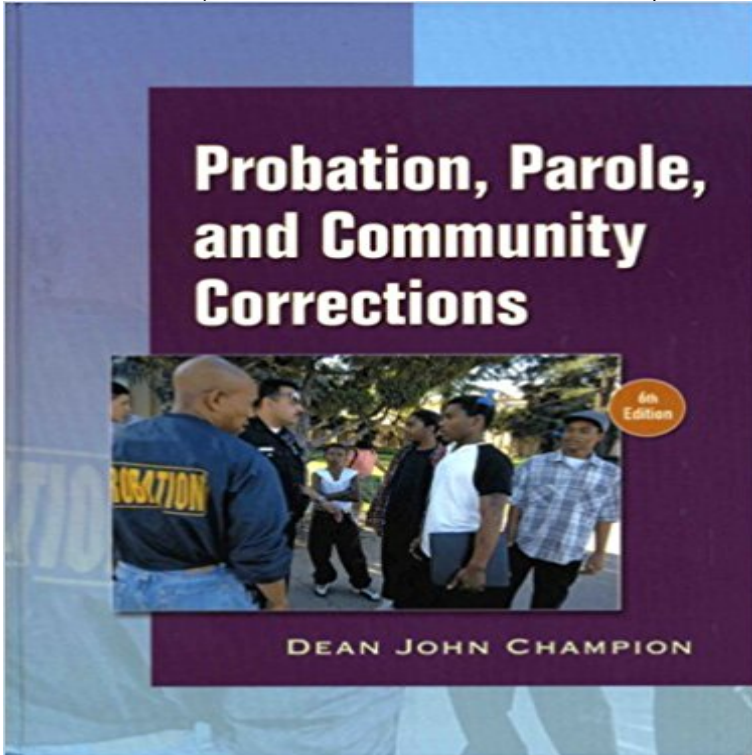


Probation, Parole and Community Corrections (6th Edition)
