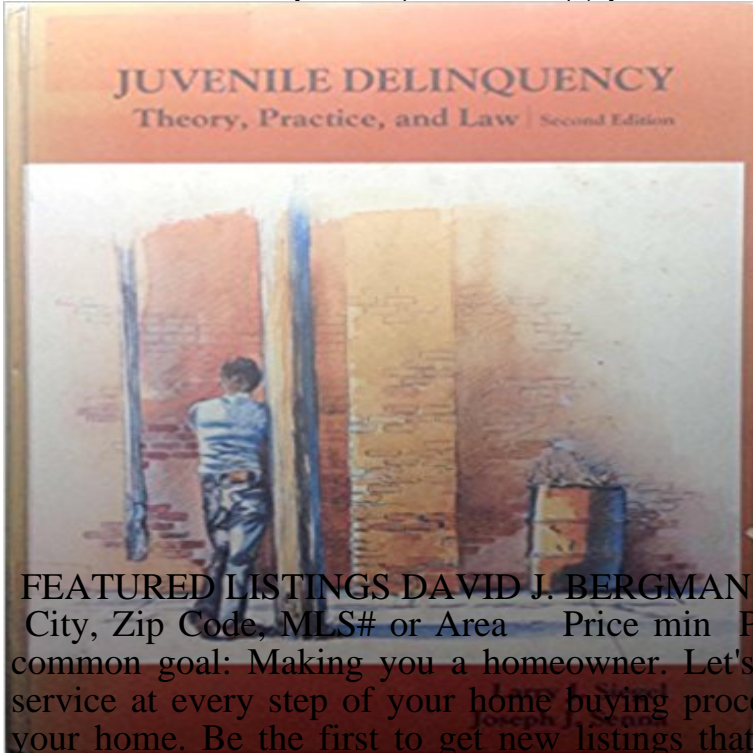


Juvenile delinquency: Theory, practice, & law
