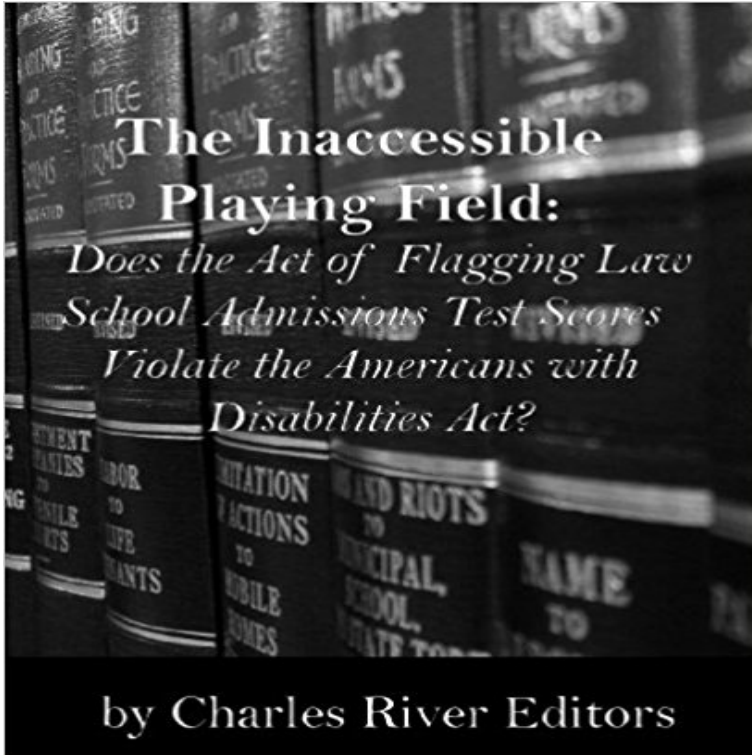


The Inaccessible Playing Field: Does the Act of Flagging Law School Admissions Test Scores Violate the Americans with Disabilities Act?
