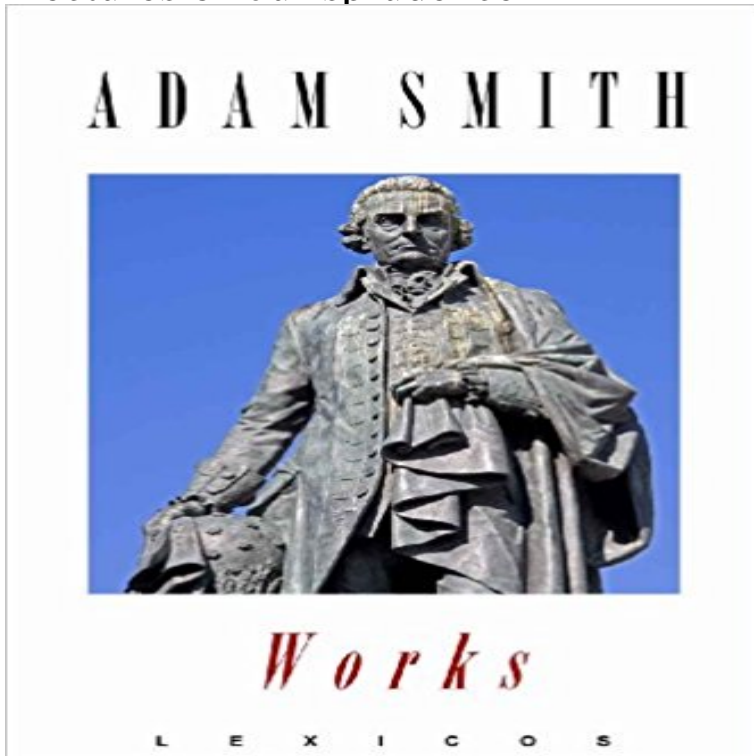


## Lectures on Jurisprudence
